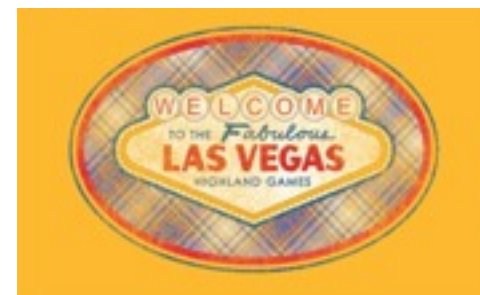

10. Dancers will dance in inverse order of entry.
