Competition Rules

- SOBHD rules will be followed.
- Last to enter first to dance rules apply.
- All dancers must have a 2011 registration card to receive awards.
- Communication by a dancer or parent of a dancer with the judge or piper is not allowed and is grounds for disqualification.
- All competitors are expected to comply with the Code of Ethics as printed by FUSTA.
- Behavior by any competitor considered unacceptable, whether on or off the platform, that disrupts the competition, competitors, organizers or judge may be grounds for disqualification from the competition as decided by the organizer(s) and/or the judge.
- Any dancer not on hand when their event takes place will forfeit their entry in that event.
- All dances, except those specified as Special Dances, count towards trophy.
- Awards for Premier 16 & Over Dances—1st place - \$20, 2nd place - \$15, 3rd place - \$10.
- Age groups will be determined after all entries have been received. Organizer reserves the right to split or combine classes the day of the competition.
- Any protest must be handed in writing to the appropriate committee, properly signed, and accompanied by a fee of \$10. If protest is sustained, fee will be returned. Protests must be made immediately following posting of results.
- The Most Promising Beginner plaque is awarded to the judge's selection from Beginners of all ages. The Most Promising Pre-Premier 21 and Over plaque is awarded to the judge's selection from Beginner, Novice and Intermediate dancers 21 and over. The Vera Miller Patterson Sword Challenge and Premier Challenge Cup is awarded to the respective winners in each dance-off.

HIGHLAND DANCING COMPETITION INFORMATION

Entries are due by **May 28th**. Late entries will be accepted with a late fee of \$5. Please **TELEPHONE** or **EMAIL** if you are mailing a late entry the week of the games or if you will be registering on the field. A confirmation email will be sent. If confirmation email has not been received by **June 1st** please contact registrar. Entry fee includes admission to the field. A competitor list will be at the entry gate. No competitor numbers will be mailed in advance.

(If there are sufficient entries, there will be a Premier 21 & Over class.)

SPECIAL DANCES:

VERA MILLER PATTERSON SWORD CHALLENGE: 3&1 Sword. Open to all Premier age 15 and under dancers.

TUOLUMNE RIVER HORNPIPE CHALLENGE CUP: 6 Step Sailor's Hornpipe. Open to all Premier age 16 and over dancers

CHOREOGRAPHY:

- Solo
- Duo
- Group (3+ dancers)

Groups must consist of all Premiers or all Pre-Premiers. A group consisting of Pre-premier and Premier dancers will be classified as Premier. Music and steps should be primarily Highland or National dance themed; music not to exceed 3 minutes. Props and costumes may be used.
