Registration will begin promptly at 8:30am with dancing commencing at 9:00am. The Highland Dance Competition will run in accordance with SOBHD regulations. All dancers must present a valid SOBHD card to compete. Competitors will be divided by age as of July 9, 2011, and the number of entries received. Dances will be danced in the order they are listed. The Premier level reel will be danced first by the group with the largest number of participants, to allow for fill-in's in the smaller group. Premier groups will be as follows: 7 and Under 15, Over 14.

An aggregate trophy will be awarded to the overall winner of each group. Premier will be awarded 2 trophies per group: one for Highland, and one for Scottish National. No trophy will be awarded in Primary. Premier aggregate winners will receive a 50% reduction on their 2012 entry.

Mailed entries will be accepted until June 30, 2011. Any entries postmarked after this date will be subject to a \$10 late fee. Field entries will be accepted with an additional \$15 competition day charge. All competitors will receive an e-mail acknowledgement of their registration. \$1 from each entry will be donated to FUSTA Southwest.

The decisions of the Adjudicator are final. Petitions should be filed to the Dance Chairman no later than 15 minutes after the awards presentation. The petition should be in writing and accompanied with a \$25.00 fee that will be refunded if petition is warranted.

Please note: Due to church rules, no caffeinated beverages will be allowed past the entry alcove. We will have a table set-up there for you to leave your caffeinated beverages.
